The undersigned hereby releases, waives, discharges and covenants not to sue THE 35th TAE RYONG CUP TAEKWONDO CHAMPIONSHIP Committee, the Tae Ryong Taekwondo School, Santa Clara High School, Archdiocese of Los Angeles Education Corporation and/or their respective officers, directors, agents, representatives, referees, employees, managers, trainers, instructors, and/or any other person (herein after referred to as "releases") from any liability to the undersigned, his or her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demand therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence of the participants or otherwise while the undersigned is in, upon or about the premises of any facilities or equipment therein or is observing or participating in THE 35th TAE RYONG CUP TAEKWONDO CHAMPIONSHIP whether at the premises or facilities or otherwise. I acknowledge, however, that THE 35th TAE RYONG CUP TAEKWONDO CHAMPIONSHIP and the Tae Ryong Taekwondo School does not warrant the protective equipment and that it is my responsibility to provide such equipment for my own use in the competition.
